Grading scheme

In the Spanish university system, modules/courses are graded on a scale of 0 to 10 points with the following qualitative equivalence:

0-4.9: "suspense"; 5-6.9: "aprobado"; 7-8.9: "notable"; 9-10: "sobresaliente". A special mention, "Matrícula de Honor" may be granted to up to 5% of the students in a group provided they have got a "sobresaliente". To pass a module/course it is necessary to get at least 5 points.

In cases of recognition of ECTS, professional experience, cultural or sports activities, or student representation no grading will be recorded but, where appropriate, the word "Apto".

INFORMATION ON THE FUNCTION OF THE QUALIFICATION

Access to further study

This qualification gives access to Doctoral studies, provided that the student has completed a minimum of 300 ECTS in the overall teachings of Bachelor and Master.

Stated objectives associated with the qualification and professional status (if applicable)

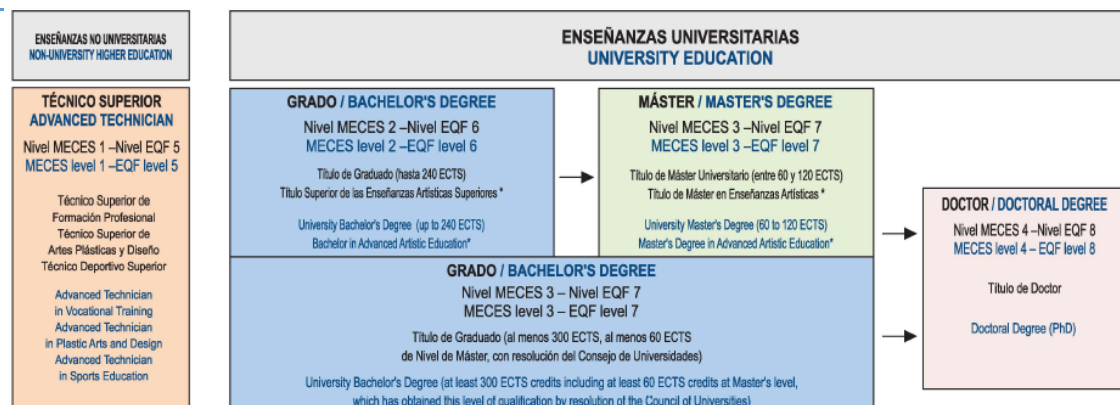
This Master's degree aims at training Political Science and other Social Science graduates academically and professionally. The Master's offers highly specialized training in four fields of Political Science study: governance and public policies, political analysis, comparative politics, and international politics. To guarantee this training, the Master's program includes compulsory modules on research methods training and optional specializations from which students can choose.

The main competences that students acquire are: being able to use the methodology of Political Science and Social Sciences to design scientific and applied research; elaborating academic and professional papers, and original scientific research projects in Political Science; to explain complex political and social phenomena through scientific and professional research integrating Political Science knowledge and presenting and communicating scientific knowledge based on research projects and on their results.
